TURN at Roundabout at Western end of Ashford By-pass

(14m. 1547yds.)

Retrace along A.20 and A.2020 to

FINISH by flagstaff outside "Tudor House" at Bearsted

(15m. 213yds.)

The following Regulations must be observed :

- No. 4 No Teams or Riders shall take shelter from other vehicles or from members of other Teams.
- No. 5 The normal formation shall be single file, with the minimum amount of echelon to allow a view ahead. In passing other vehicles, Teams shall always form single file.
- No. 6 No racing between members of a Team or between Teams or individual Riders is permitted. If one Team overtakes another the onus shall be on the overtaken Team to avoid such racing by dropping back if necessary.
- No. 7 Every Rider in a Team Time Trial shall be separately responsible for keeping a continuous look-out ahead and obeying all laws, road signs and Police signals.
