- \* The start is reached by proceeding SW along A.3 and turning around the Ockham roundabout and retracing along the London bound carriageway of A.3. The distance from HQ to the start is approx 2 miles.

- \* Riders must not in any circumstance cross the two carriageways and central reservation of the A.3 to reach the start.

START between 5th and 6th drains (150yds) NE of bus stop in lay-by off London bound carriageway of A.3 at Wisley Gardens

PROCEED NE along A.3 for 5 miles to

FORK LEFT (M) at A.244 intersection, down sliproad to

TURN around Oxshott roundabout (C + M) taking 4th exit to climb up to Guildford bound carriageway and continue along A.3 to

5.40m

FINISH approx 1/4 mile after Downside Lane at a point 85 yards after "Services 1M" sign

- \* On finishing riders must continue along A.3 and turn into Effingham Lane before dismounting.
