

COURSE DETAILS - E.72

Intermediate
Mileages

START - At end of bridge, south side of flyover
at the London end of the Witham by-
pass to A.12.

Proceed west to join A.12 and shortly
take slip road to Hatfield Peverel.

Again shortly, turn sharp right to cross 0.68m
the A.12 and rejoin A.12 travelling in
an easterly direction to the Stanway
by-pass.

There go left onto the slip road to A.604
and turn at elevated roundabout to 14.41m
rejoin A.12 by means of the slip road.

Follow A.12 in London direction to the
start of the Witham by-pass where go left
onto slip road towards Witham (B.1389).

FINISH Cross bridge over A.12 and then turn left
into Freebourne Road to finish at LP.30
facing centre of entrance to Wheaton Road,
at far end of Freebourne Road. 25.00m

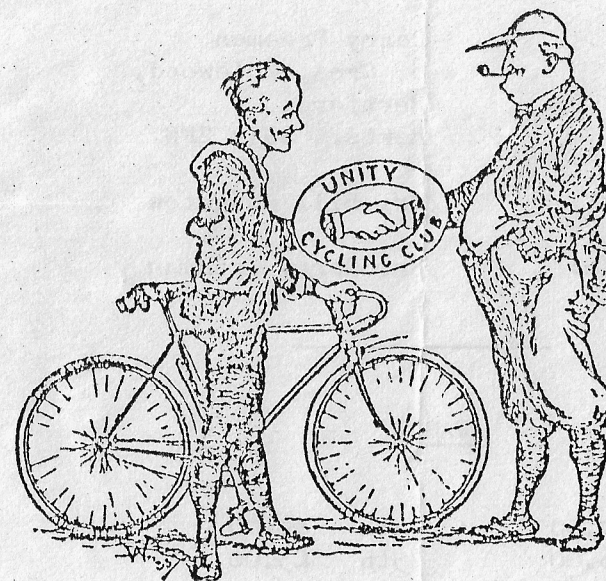
