REVISED COURSE ---

START on the A.267 just south of Hellingly Village Hall traffic island, opposite the RAC sign. Proceed to Boship Roundabout and take third exit onto the A.22. Stay on the A.22 through Golden Cross and Halland and onto the Uerfield by-pass to the junction with the A.26 at the LITTLE HORSTED ROUNDABOUT (9.959 miles), where LEFT on the A.26.

Continue on the A.26 to the Snail sculpture opposite the entrance to the Culfail Tunnel at LEWES (16.896 miles), where TURN round the snail.

RETRACE to the LITTLE HORSTED ROUNDABOUT (23.833 miles), where TURN RIGHT WITH TOREST CARE onto the A.22 and continue to the Boship Roundabout. Take the first exit onto the A.267 to FINISH at the drain under power cables, just short of the start (33.750 miles).

EVENT HEADQUARTERS: Union Corner Hall, Hawks Road, Hailsham - about ten minutes' riding time from the start. The result board will be there.

NUMBERS will be available AT THE START, and should be returned to event headquarters in exchange for a cup of tea.

THE COURSE has had to be changed from the usual one because of the roadworks at Firle. Don't forget to stay on the A.22 through Halland and join the new Uckfield by-pass.

REGULATIONS governing team time trials are on Pages 77 and 78 of the RTTC Handbook. They include the rule that each member of a team "shall be attired in jerseys of similar colour and design"; that "the normal formation of a team shall be single file with a minimum amount of echelon to allow a view ahead for each rider"; and that "the time of a team shall be that recorded by the last member of the complete team to finish."

IT IS A DISTRICT COUNCIL REGULATION THAT NO VEHICLE SHALL BE PARKED ON THE ROADWAY WITHIN SIGHT OF THE START AND FINISH.
