NOTES FOR RIDERS, HELPERS AND SPECTATORS

1. London East Local Regulation 1/86 relating to Course E.72.
 - A) Riders must not cross the lane markings when they turn left into Freebourne Road, Witham immediately prior to the finish.
 - B) Any rider crossing the lane markings is to be immediately disqualified from the event and reported to the London East District committee.

2. The majority of the course is on the A.12.

The exceptions are:

 - i) the A.134 section at Colchester
 - ii) the approaches to the Chelmsford By-pass at Margaretting and Boreham. At both places, for riders safety, the course leaves the A.12 at a slip road and rejoins it after a roundabout.

3. A free drink will be available at the finish in exchange for your body number.

4. FINISH - Keep well clear of the finishing line and the area in front of the timekeeper. The timekeeper WILL NOT ANSWER ANY QUERIES, except those made via the Result Board Official.

5. Riders wishing to use a vehicle as provided for in regulation 51 should supply the following details to the Event Secretary before their start times:

E.72/100 Course details:

START at "Give way" sign adjacent to rear exit of garage in B.1389 Witham, near old E.72 '25' start at Wood End Bridge. (this is two miles west of Freebourne Road junction with B.1389). Proceed via slip road onto Clchester bound carriageway to junction east of A.604 fly-over, where keep left (M) leaving A.12 (direction A.134, Colchester) to Spring Lane roundabout (M). Proceed along Cymbeline Way (Avenue of Remembrance) to the A.134/Westway roundabout, Colchester. TURN (M. and C.) - (15.35 miles) and retrace to the A.12 and continue to the Boreham Interchange, where keep left (M) up to elevated roundabout, taking 2nd exit (M. and C) to rejoin the A.12. Proceed to Mountnessing where Left up slip road (M) to elevated roundabout where TURN(M. and C.) - (49.07 m.) and retrace to Margaretting. Take slip road (M) into A.1026 to roundabout, taking second exit (M) up slip road to rejoin A.12. Proceed to take slip road at A.130 underpass (M) to roundabout, turning Left (M) onto A.130 to Army & Navy roundabout, Chelmsford. TURN (M. and C.) - (61.27 miles) and retrace to A.12 where Left up slip road to join eastbound carriageway. Proceed along A.12 to slip road just west of A.604, Stanway. Turn Left (M) up slip road to fly-over where Right over A.12 (M) and taking first exit (M) proceed to Tollgate roundabout. Turn Right (M) into B.1408 to Marks Tey roundabout. TURN (M. and C.) - (87.25 miles) and retrace to the Tollgate roundabout where Left (M) to A.604 flyover where Left again (M) down slip road to join London-bound carriageway of A.12. Proceed to eastern end of Witham By-pass where Left up slip road (M. and C.) crossing fly-over into B.1389. Turn Left into Freebourne Road (M) to FINISH at drain, 25 yards west of L.P.13 (10 yards east of L.P.14 opposite), by junction with Moss Road.

NOTE: Only temporary parking near start adjacent to Public Toilets. All long stay parking to be in Freebourne Road and Moss Road, west of Finish area.
