Since the last meeting some of the Committee had discussed and agreed to send Arthur Edwards a complimentary ticket as he could no longer afford to attend. This had been done and a letter of thanks from Arthur was read out by the Chairman.

Xmas Tea 1990: This was held as arranged on December 16th at the Ash Tree Inn with 15 attending.

The transport arrangements made by Esther worked very well and a £10 donation was made to the charity concerned.

It was felt that the meal was not good value for the money and it was decided to cancel the provisional booking for 1991 until nearer the time when other suggestions would be discussed.
